Production Costs, as requested by you, will be billed as actually accrued on a monthly basis and are due on receipt of our invoice. Production costs include website revisions, website development, video development and production, audio development and production, graphic design creation and copywriting for items such as articles and white papers.



Expenses, as requested by you, will be billed as actually accrued on a monthly basis and are due on receipt of our invoice. Reasonable travel expenses include full coach airfare, taxi, car rental, hotel, meals and tips. We do not bill for fax, courier, administrative work, telephone, duplication or related office expenses.

Conditions: The quality of our work is guaranteed. In the event that you feel that we are not meeting the standards described herein or based on our mutual conversations and agreements, this agreement may be cancelled given 30-days written notice.

Payment Terms. Payment is due on the 1st of the month for every month of service. Hourly, per-item and one-time fee options will be invoiced after they are completed and delivered, on a monthly basis. We accept company checks, credit cards, PayPal and wire transfers.
